Motion authorizing Attorney Hassey to advertise an amendment to the Exeter Borough Maintenance of Private Property Ordinance, section 34.7 E Fences, to adopt new setback for installing fences. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Mr. DeRoberto and unanimously carried.
