Ron Rome of Wyoming Ave asked about the Ashburn Advisors agreement. Mr. Murawski stated the agreement is a contract.

Ms. Morgan of Sullivan St. asked about open shifts on the police schedule. Police Commission Harden said the schedule is constantly being worked on and updated.

Ms. Tracy of Wyoming Ave asked about getting information on the going's on in Exeter Borough. Police Commissioner Harden stated the police department has an updated Facebook page.

Lucy Morgan of Sullivan St. said Luzerne County has a notification system that Exeter Borough can use to send out emergency messages.

Ms. Balent of Grant St. asked how many members of the Police Committee had their cars broken into and how many members of the audience had their cars broken into. She wants police.

Mr. Rome of Wyoming Ave what happens if you can't find police officers to work. Mr. Dellegrotto stated that according to the police contract a Police Chief cannot cover open shifts.

Mr. John Gilligan of Wyoming asked what is the liability to Exeter Borough if there are only Part Time Police Officers. Atty. Hassey said that we have training for all officers.

Mr. Frank Pizano of Wyoming Ave. asked where is the money for the full time police force and how much was spent on legal bill from 2015 and 2016. Mr. Dellegrotto will research and study the budget along with the Finance Committee. The amount spent on legal bills was not known at the meeting. Mr. Pizano can put in a request for information to obtain this information.

Ms. Pat Morgan of Lincoln St. asked about the fire hydrant on Cedar St. The hydrant has been hit by a car and the water company will be replacing the hydrant.
