Motion to accept pay request #1 from Fehlinger Construction Group in the amount of \$7,452.00 for the Stormwater Improvement Project as approved by Harold Ash of PennEastern Engineering. 1st Mr. Turner, 2nd Ms. DeRoberto and unanimously carried.
