Motion authorizing Atty. Hassey to advertise the Property Tax Mileage Ordinance for 2020. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Morgan and unanimously carried.

Motion to approve \$1,100.00 payment annually to Debra Serbin, in lieu of having to pay health insurance required under her employment contract. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Dellegrotto, Roll Call; Mr. Morgan – no, Mr. Balent – no, Mr. Dellegrotto – yes, Mr. Murawski – yes, Mr. Pizano – no, Ms. DeAngelo – no, Mr. Esposito – yes.

Motion to transfer \$25,000.00 from the 1<sup>st</sup> National Sewer Fund to the General Fund for administrative duties associated with the Borough Manager, insurances and the 2019 building utilities. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Mr. Pizano and unanimously carried.

Motion to transfer \$13,648.00 from the Refuse Fund to the General Fund as reimbursement of the 2019 salaries associated with the Refuse Clerk and the Recycling Coordinator. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Ms. DeAngelo and unanimously carried.

Motion to transfer \$23,512.00 from the Refuse Fund to the General Fund as reimbursement for Recycling/Refuse expenses paid from the Exeter Borough General Fund. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Mr. Balent and unanimously carried.

Motion to accept Pay Application #1 for the Washington Street Pave and Drainage Project from Stafurski Paving Company in the amount of \$30,233.44 payable from the 2011 Flood Fund. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Balent and unanimously carried.

## **NEW BUSINESS**

Motion to approve the current bills in the amount of \$197,209.88. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Mr. Esposito and unanimously carried.

Motion to eliminate the curb side recycling pickup for all Exeter Borough businesses effective March 31, 2020. Exeter Borough will send notice letters to the affected businesses informing them of the change and their mandated responsibility to recycle and sending the weight slips to Exeter Borough. Motion to table the motion. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Balent and unanimously carried.

Motion to hire Kohanski & Company, PC, to perform an audit of the General Fund for years 2016, 2017, 2018, 2019. The fee for providing there services will be \$6,050.00 based on a budget of 60 staff hours. 1<sup>st</sup> Mr. Balent, 2<sup>nd</sup> Mr. Morgan, Roll Call: Mr. Morgan – yes, Mr. Balent – yes, Mr. Dellegrotto – yes, Mr. Murawski – yes, Mr. Pizano – yes, Ms. DeAngelo – yes, Mr. Esposito – yes.

Motion to accept Resolution #11-2019 authorizing the submission of the LSA Grant application titled "The Luzerne County Luzerne Loan Project" in the amount of \$500,000.00 on behalf of Metro Action, Scranton Chamber of Commerce. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Ms. DeAngelo and unanimously carried.

Motion to approve the agreement between Exeter Borough and Scott Hughes to extend the probationary period of his employment until July 2, 2020, on the condition that Mr. Hughes sign and return the agreement to the Borough Manager on or before January 2, 2020, with the failure of such to result in automatic termination on that date. 1<sup>st</sup> Mr. Morgan, 2<sup>nd</sup> Mr. Pizano and unanimously carried.

Motion to approve the dedication of easement agreement from Carey-Atlas Development LLC, in regards to the Carey-Atlas Subdivision, subject to all conditions of approval having been satisfied. 1st Mr. Morgan, 2nd Mr. Balent and unanimously carried.

Motion to eliminate the GPS in the Police vehicles. 1<sup>st</sup> Mr. Balent, 2<sup>nd</sup> Mr. Pizano and unanimously carried.

Motion to eliminate Atty. Hassey and name Debra Serbin as the Right to Know Officer for Exeter Borough. She will attend the necessary training. 1<sup>st</sup> Mr. Balent, 2<sup>nd</sup> Mr. Pizano and unanimously carried.

## Open to the Public:

Mr. Larry Dellegrotto thanked everyone for the honor of serving the residents of Exeter Borough.

Ron Rome of 1009 Wyoming Ave asked what about the previous payments that Ms. Serbin received as a buy out in lieu of medical. Atty. Hassey said that Council passed those payments and he is okay with it.

Larry Marchetti of 273Harland St. spoke to Council about the need to have a contract with PennEastern Engineering for our engineering services. Atty. Hassey will look into the matter. Mr. Marchetti said he believes that offering the work to more than one engineering company would be good for the Exeter Borough taxpayers. Mr. Balent will also look into this matter. Mr. Marchetti asked if the O&M Fund is for sewer work. The answer to his question was, yes that fund in for sanitary sewer work.

Lindo Sabatini of 3 Fairway Drive questioned Council about selling refuse/recycling stickers. No business recycling sticker will be sold for 2020 until the Council and the Recycling Coordinator can work on a plan for the businesses.
