Motion to approve the updated job description for the Police Commissioner William Harden. 1st Mr. Esposito, 2nd Mr. Dellegrotto and unanimously carried.

Motion to accept pay request #2 (final) from Spotts Brother in the amount of \$12,300.00 for the Recycling Roof replacement Project as approved by PennEastern Engineering. 1st Mr. Morgan, 2nd Mr. Dellegrotto and unanimously carried.
