- 3) Council does hereby ordain that the former Section 97-6 and Section 97-14 shall be replaced with the following:
- 97-6-1. License Fees. No license shall be issued under this Chapter until the proper application has been make on such form as the Borough may establish and fee as follows shall have been paid to the Mayor which fee shall be for the use of the Borough:
- A) For itinerant merchants, peddlers, solicitors or canvassers, \$500.00 per month, for each month or partial month they may operate. Licenses shall be renewed monthly upon payment of the license fee as herein provided;
- B) Transient retail businesses, \$500.00 per month, or fractional part of a month, for each month or partial month they may operate. Such license shall be renewed monthly upon payment of the license fee as herein provided.
- C) All fees can be modified by Resolution of the Borough Council of Exeter. 97-14-1. Violations and Penalties. Any person or entity who shall violate any provision of this Chapter, upon conviction thereof, shall pay a fine of \$1,000.00 per occurrence, plus costs of prosecution, and in default thereof, be sentenced to a term of imprisonment of not more than 30 days. Each day that a violation occurs shall constitute a separate offense. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Turner, Roll Call; Mr. Morgan yes, Mr. Shannon yes, Mr. Dellegrotto yes, Mr. Turner yes, Mr. Pizano yes, Ms. DeRoberto yes, Mr. Esposito yes.
