Larry Marchette of 273 Harland St. had questions on the purchase of 1125 Wyoming Ave. He wanted to know what the Borough has planned for the property. The Borough will demolish the building and hopes to make it available for public use. He would also like to be part of any crime watch citizens group should it be established.

Paula Tracy of 1210 Wyoming Ave reported that her sidewalks are lifting due to a tree that the Borough planted. She is asking for assistance from the Borough as she does not want anyone to trip on the sidewalk. Mr. Murawski will go and take a look at the situation.

Phil Knobel of 312 Lincoln St. wants to know what the Borough will do on Susquehanna Ave if we get another flooding event. He does not want another dike built in front of his mother's home on Susquehanna Ave.
