Motion to hire Joseph DeMark of Wyoming Ave as a part time as needed Police Patrolman. 1<sup>st</sup> Mr. Esposito, 2<sup>nd</sup> Mr. Morgan and unanimously carried.

Motion to participate in the Electronics Recycling Event sponsored by the West Side COG on November 2, 2017 at the Luzerne County Soccer Fields – Forty Fort. Each town will be

expected to commit at least one laborer and one police officer to this event. 1<sup>st</sup> Mr. Pizano, 2<sup>nd</sup> Mr. Dellegrotto and unanimously carried.

Motion to place out for bid curb side recycling pick-up from January 1, 2018 to June 30, 2019. Option 1 with the use of Carts and Option 2 without the use of Carts. Also the Option to split the town into 2 zones for alternating weeks recycling verses same day once a week recycling. 1<sup>st</sup> Mr. Dellegrotto, 2<sup>nd</sup> Mr. Esposito, Roll Call: Mr. Morgan – no, Mr. Shannon – yes, Mr. Dellegrotto – yes, Mr. Pizano – no, Ms. DeRoberto – yes, Mr. Esposito – yes.

Dave Balent of 304Grant St. wants Council to address the need for street work in Exeter. Donna Morgan of Sullivan St. had questions pertaining to sewers on Sullivan St. Council will research the matter.

Lindo Sabatine of Wyoming Ave wants to make sure that Exeter Borough has Police coverage. Council stated that the town does have police protection at all times.

Mary Pat Coleman of 1304 Wyoming Ave spoke about Exeter Proud and asked for volunteers to fill positions that are available.
