## **MINUTES**

Report of Committees:

Police/Wyoming Area Regional Police (WARP): Chief Turner provided report, on file. 166 of 520 calls were Exeter Borough. Chief commended officers for response to West Wyoming shooting, rapid response in 4am Pizza L'Oven cooking oil theft; Chief announced anti-drug motivational speaker at Wyoming Area Secondary Center 4/8; bike patrol to begin mid-April. Vice Chairman Morgan commended Chief, officers for outstanding service. Councilwoman DeAngelo inquired about Pizza L'Oven locking oil repository to prohibit repeat theft.

Finance & Insurance (Grants): No report at this time.

Fire Department: Councilman Murawski read report, on file.

Streets/Recycling: Councilman Balent reported Laird, Cedar, Orchard need repair; Vince Ninassi reported creek inspection will be April 15th.

Parks & Recreation: Councilwoman DeAngelo announced CodeRed to be sent to announce Easter Bunny, 4/12; Yard Sale, May 24; Streets Department will add mulch to the Borough parks.

WVSA: Vice Chairman Morgan reported 41 sanitary sewer lines flushed; 11 lines checked on camera, 15 storm basins vacuumed; report provided by WVSA, on file. List of storm catch basins to be cleaned needs to be sent to WVSA; Collapsed line on Mundy St. will be repaired with paving project; Stormwater balance should be used to fund separation project; WVSA will begin street sweeping in June 2025; Ordinance is needed for WARP to enforce WVSA No Parking Street Sweeping signs.

Zoning: Councilwoman DeAngelo read February report, on file. Total deposit \$3.601.46. DCED reports note gaming revenue should be reported; Chief Turner said one letter be used, WARP can visit businesses to count machines, ordinance must be in place with penalty provisions for noncompliance.
