

ORDINANCE # 2 of 2026
GARBAGE COLLECTION STICKER FEE

WHEREAS, Council for the Borough of Exeter, by this ordinance, does hereby amend Chapter 66, Article IV of the Boroughs Code of Ordinances to establish a new fee schedule for Garbage Collection Stickers.

BE IT DULY ORDAINED AS FOLLOWS:

1. Chapter 66, Article IV of the Exeter Borough Code of Ordinances, establishes the standards and requirements for the purchase of Garbage Collection Stickers.
2. Section 66-12 (A) requires that "...all persons, residents, corporations, businesses, associations...who own any structure...used in whole or in part for residential purposes...to purchase a garbage collection sticker from the Borough of Exeter."
3. Section 66-12(B) gives owners of structures in the Borough "...used for commercial purposes" the option to purchase a garbage collection sticker from the Borough.
4. Purchase of a garbage collection sticker entitles the owner the right to dispose of six (6) garbage bags, per specifications permitted by ordinance, and one (1) bulk item weekly, pursuant to the Borough's contract with the garbage collector.
5. The cost of the annual garbage collection sticker is hereby established to provide for a rate for Senior Citizens, Regular Rate and a Business Rate, and to provide for a Discount Rate, Face Value and Penalty Rate for each category as follows:

Permit Type	Discount	Face Value	Penalty
Senior	\$350.00	\$360.00	\$470.00
Regular	\$395.00	\$410.00	\$560.00
Business	\$680.00	\$700.00	\$850.00

6. Failure to purchase a garbage collection sticker shall subject violators to the penalties established by ordinance.
7. For multifamily residential buildings, or structures which contain residential units and other nonresidential uses, the owner shall be required to purchase an individual garbage sticker for each residential unit in the structure.
8. The owners of commercial establishments which elect not to purchase a garbage collection sticker from the Borough are required to provide for the removal of municipal solid waste, by independent contract or otherwise.

9. Failure to comply will subject violators to the penalties established by ordinance and otherwise under law.
10. All remaining provisions of Chapter 66 shall remain in full force and effect.
11. This Ordinance shall take effect immediately upon enactment, and shall be effective commencing the year January 1, 2026, and shall continue until such time as may be modified by further act of Council.

NOTICE IS GIVEN that Exeter Borough Council will consider adoption of the following Ordinance at its regular meeting on January 6, 2026 at 7 p.m., at 1101 Wyoming Avenue, Exeter, PA. An Ordinance establishing the Garbage Collection Sticker Fee. Section 66-12 (A) requires that "...all persons, residents, corporations, businesses, associations...who own any structure...used in whole or in part for residential purposes...to purchase a garbage collection sticker from the Borough of Exeter." Failure to purchase a garbage collection sticker shall subject violators to the penalties established by ordinance. For multifamily residential buildings, or structures which contain residential units and other nonresidential uses, the owner shall be required to purchase an individual garbage sticker for each residential unit in the structure. The owners of commercial establishments which elect not to purchase a garbage collection sticker from the Borough are required to provide for the removal of municipal solid waste, by independent contract or otherwise.

Failure to comply will subject violators to the penalties established by ordinance and otherwise under law. The public is invited to attend.
