Motion to Approve Resolution #12 of 2026 (*amending funding request Resolution #8 of 2026*) to request \$3,000,000 for DCED Multimodal Transportation Fund Program - Exeter Borough - Wyoming Avenue-Schooley Avenue Sidewalk and Streetlight Project, including Exeter Borough matching funds commitment letter for \$667,272 administrative, engineering, and contingency costs beyond grant amount. Motion made by Councilwoman DeAngelo; seconded by Councilman Murawski; motion passed unanimously.
2. Motion to Approve Resolution #13 of 2026 (*amending funding request of Resolution #10 of 2026*) to request \$805,345 for Luzerne County FY2027 CDBG Funds for street pave and curb projects on Luzerne County-approved streets. Motion made by Councilman Balent; seconded by Councilwoman DeAngelo; motion passed unanimously.
3. Motion to Approve Resolution #14 of 2026 to request \$1,000,000 LSA grant funding for Susquehanna Avenue Storm & Sanitary Sewer Separation Project North - Phase 2, including Exeter Borough matching funds commitment letter for \$381,149 for administrative, engineering, and contingency costs beyond grant amount. Motion made by Councilman Balent; seconded by Councilman Murawski; motion passed unanimously.
4. Motion to Approve Letter of Support for \$150,000 DCED LSA grant request for Northeast Sight Services, Exeter, PA, HVAC system repair project. Motion made by Councilman Balent; seconded by Councilman Esposito; motion passed unanimously.
5. Motion to Approve Letter of Support for \$250,000 DCED LSA grant request for Greater Pittston Regional Compost, Dupont, PA, 2010 Bandit 2460 Grinder five-year service project. Motion made by Councilman Balent; seconded by Councilwoman DeAngelo; motion passed unanimously.
